

2017 EAST HUSKER CONFERENCE SOFTBALL INFORMATION SHEET

SATURDAY, SEPTEMBER 23, 2017

- LOCATION: Games are played in Madison. The ballfields are located at Memorial Park which is located on the west side of N. Main street on the north end of town.
- ADMISSION: **ADULTS \$5 STUDENTS \$4 (kids four and under are free)**
Teams, including bus drivers, coaches, players and team support personnel will be admitted as a group when they arrive. CONFERENCE PASSES WILL BE HONORED FOR CARDHOLDER AND SPOUSE.
- ENTRIES/SEEDS: PLEASE FOLLOW THE PROCEDURE FOR SEEDING THE TOURNEY AS GIVEN ON PAGE 7 OF THE CONFERENCE BYLAWS FOR SOFTBALL BY NOON ON THE 18th OF SEPTEMBER
- LOCKERS: Locker rooms will not be available.
- SEATING: We have bleachers at each diamond.
- BALLS: **Each team will provide 2 game balls for each game**
- WARMUPS: Teams will be notified of warm up procedures at the conclusion of each game. You can probably count on a maximum of 15 and a minimum of 10 minutes between games. There is an additional field for warm ups that won't interfere with the games in progress.
- PARKING: School busses should unload team and personnel at the ball field and then park on the east side of Union Creek Road facing north.
- PROCEDURES: Games are scheduled for seven innings with a **1 ½ HOUR TIME LIMIT**. The tie breaker shall automatically begin in the eighth inning. Eight, ten and twelve-run rules apply to all games. The higher seed shall be the home team in all games and occupy the 3rd base dugout.
- FANS: ***PLEASE PAY ATTENTION AND INFORM YOUR STUDENTS/FANS OF THE LIST OF FAN/SPECTATOR ITEMS THAT ARE ALLOWED AND NOT ALLOWED AT DISTRICT GAMES IN THE NSAA SOFTBALL MANUAL***
- TEAMS: HIGHWAY 91, LOGAN VIEW/SCRIBNER-SNYDER, MADISON/HUMPHREY/LINDSAY HOLY FAMILY, NORTH BEND, TEKAMAH-HERMAN, TWIN RIVER, WEST POINT-BEEMER, WISNER-PILGER/PENDER/BANCROFT-ROSALIE
- TIMES: Game time is 9:00 for 1st round games, with a 10-15 minute break between games for the rest of the day. If Saturday tournament play is suspended due to weather, the tournament will continue on the Monday alternate date with affected games resuming from the point of suspension with respect to players counts on the batters and game time remaining on the clock. If a player from a suspended contest is unable to play on the Monday alternate date, a substitution must be made.
- HOSPITALITY: Each team will be provided with four meal tickets to be used at the concession stand for coach/team/administrative personnel.
